## Terms & Condition

- The firm must have valid NTN, GST Number, C-6 & CE-10 certificate. NTN & GST verification certificate from website of FBR may be attached with tender.
- 2. Bid documents should reach the office situated at NBF, Bookshop, 1<sup>st</sup> Floor, Public Library, Jalal Baba Auditorium, Abbottabad before half an hour of opening of tender i.e. on 07-07-2022 (Thursday). Bid shall be opened on the same day at 12:00 pm in presence of bidders or their authorized representative at NBF, Bookshop, 1<sup>st</sup> Floor, Public Library, Jalal Baba Auditorium, Abbottabad.
- 3. Bid received after closing time will not be entertained. No telegraphic or faxed bid will be accepted.
- 4. Authorized representative of the firm must sign and stamp the bid documents and rate / bid proforma.
- 5. The rates should be quoted in the prescribed rates / bid proforma enclosed herewith at Annex-I.
- 6. Earnest money in shape of Pay Order/Demand Draft in favour of National Book Foundation @ 2% of quoted price / rates should be attached with bid, which shall be refunded to unsuccessful bidders. The bid money of successful bidder will be released after satisfactory completion of the work.
- 7. The work should be of best quality and finishing to the entire satisfaction of NBF authorities.
- 8. The work will be completed within 20 days with 5 days grace period after issuance of work order.

- 9. After given time period penalty of Rs.1,000/- per day will be imposed which will be deducted from the bill.
- 10. An affidavit on stamp paper of Rs.100/- should be submitted with tender documents that the firm is not black-listed and not in litigation with any Government, Semi-Government department and Autonomous body.
- 11. Black listed bidders / firms are not eligible to participate in the tender. In case of any legitimate complaint, bid money shall be forfeited.
- 12. The admissible taxes shall be deducted at source.
- 13. Payment will be made on completion of work subject to availability of funds.
- 14. 10% performance guarantee shall be submitted by the successful bidder in favour of National Book Foundation which shall be refunded after satisfactory completion of work.
- 15. Managing Director of National Book Foundation reserves the right to accept or reject all bids/proposals in accordance with Rule-33 of PPRA Rules-2004.
